I am aware of the Traffic Regulations (2012 Revision) Section 23. (3) which states, Anything affixed to, or built into, the windscreen or any window of a motor vehicle whereby the degree of light transmission in either direction is diminished below that which is specified in paragraph (a,b,c) is declared to be unsafe and, for the purpose of (a) of sub-regulation (1) is expressly disapproved.

A Public Transport Vehicle must comply with section 8(1), (2) & (3) of The Public Passenger Vehicles Regulation. (PPV)(2014 Revision) All such vehicles must adhere to the following:-

The Public Transport Board's **POLICY ON STANDARDS FOR PUBLIC TRANSPORT VEHICLES**

GENERAL: - a Public Transport Vehicle must be kept in good condition in all respects. It must be inspected on an annual basis and licensed in the category of transportation before being used on roads in a for reward or hire capacity. All such vehicles must adhere to the following:-

- A. All exterior markings displayed on the vehicle must be conducive with the category of service being carried out and must not confuse it with any other category of service.
- B. Aside from the above, no markings, except those relating to the name of the company or owner of such vehicles is to be placed on the exterior of the vehicle.
- C. All advertisements on the interior shall be professionally prepared and approved by the PTB and must relate to the category of service.
